Sir/Madam,

This has reference to the Inspection report received bearing registration EX-01511-1718 on the above subject.

In this regard, the following deficiencies / requirements have been observed during the scrutiny of the Inspection Report. The School is required to submit the specific compliance of the following deficiencies / requirements within 30 days.

- 1) The school is required to submit Fire safety certificate issued by competent authority.
- 2) The school is required to submit Recognition Certificate issued by State Education Department.
- 3) The committee has reported the following deficiencies:
 - i. The Books provided in the school library is not sufficient for the required use of the students. Many Specimen books are included in the accession register.
 - ii. PGTs needs to be appointed in all concerned subjects in full time basis instead of the part time as mentioned in the staff register.
 - iii. Qualified PTI needs to be appointed.
- 4) The Board has approved following two principals as Board nominee to be included in SMC:
 - (i) Principal, KV, Dharmadam PO, thalassery
 - (ii) Principal, JNV, Palayad nada Vadakara

Keeping in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto 31.03.2020 alongwith permission for registration of bonafide candidates of class IX/XI and submission of list of existing candidates of the School for class X/XII for current session.

However regularization of affiliation from 01.04.2017 for a period of 05 years will be subject to the specific compliance of the discrepancies communicated by the School within 30 days failing which a penalty of Rs.20,000/- per-month will be levied on the school and the process of withdrawal of affiliation of the School may also be initiated.
