The board headed by the Station Officer, Fire & Rescue Station Eloor had inspected the (G+3) storied 14.85 Meters high Multi Storied Educational Building in Survey No.57 & 76 in Edappally North Village in Ernakulam District under Kochi Corporation owned by The **General Secretary, Matha Amrithanandamayi Math, Edappally, Kochi** and recommended to renew No-Objection Certificate No. **D1-3797/12 Dated 12/11/2012** of The Regional Officer, Fire & Rescue Services, Ernakulam for the occupation of the said building Eloor for one year from 04/10/2024

2. In the circumstances, this No Objection Certificate is issued under my seal and authority for the continued occupation of the above building. No further construction will be allowed in the vacant spaces provided in the approved plan.

3. This certificate issued on the condition that the fire fighting systems installed will be kept always functional and the owner of the building should take special care to maintain the system installed in proper working condition. **This certificate is valid for one year from the date of issue. After one year the Certificate must be renewed. Non renewal of the Certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by the self Government /Revenue Department.** All officers of and above the rank of Station officer of the Fire & Rescue Services Department will have the right to inspect the building on any day/time after serving 7 days notice to ensure that the installed system are in good working condition.
