- Fire precautionary measures and first aid box should be provided.
- Overhead tank and water sump shall be hermitically sealed and scientifically closed and shall not be a breeding source of mosquitoes.
- Drinking water shall be chlorinated and shall have 0.5 ppm of residual chlorine.
- Fly/Mosquitoes breeding shall not be permitted within the premises.
- Display and exhibition of board as per rule 3 of the Tamilnadu prohibition and smoking and spitting rules 2003, Every person incharge of the place should display and exhibit board stating that this place is a "NO SMOKING AND SPITTING PLACE" and that "SMOKING OR SPITTING HERE IS AN OFFENCE".
- This certificate is liable to be cancelled at any time on infringement if any of above said conditions and for improper maintenance of sanitation & building and if any health nuisance is found as defined in Tamilnadu Public Health Act, 1939.
